How the new Schwab format changes will appear through consolidation

After conversion, but before consolidation	AAQ 05/22/2010 20.00 C	The symbol has changed to the new format, but still retains the old root symbol.
After consolidation	AAPL 05/22/2010 20.00 C	The root symbol has changed from AAQ to AAPL, the underlying

2010 important dates to remember

January 23	Conversion to new Schwab symbol
January 23	Option order entry briefly unavailable*
February 12	OCC deadline for all firms to convert to the new symbol
March 12	First consolidation: Special options
April 9	Second consolidation: "A" to "C" options
April 23	Third consolidation: "D" to "I" options
May 7	Fourth consolidation: "J" to "R" options

Fifth consolidation: "S" to "Z" options

Important reminders

May 14

Open option orders: All open orders will be converted to the new option symbol format on your behalf at the conversion and at all five consolidation events. You will not need to do anything yourself. Your order, including expiration dates, will remain the same.

Brackets and trailing stop orders: All brackets and trailing stop orders placed on option symbols will be canceled by Schwab at the conversion. In addition, brackets and trailing stop orders with an option symbol that has an underlying ticker symbol going through consolidation will be canceled at that particular consolidation event. You will need to reestablish these canceled items after each event. Please consult the Key Details section at www.schwab.com.hk/newoptionsymbols_en for detailed information on how to do this.

Alerts and conditional orders: All activated untriggered alerts and alerts with conditional orders with the old option symbols will be deactivated by Schwab at the conversion. In addition, activated untriggered alerts and alerts with conditional orders with an option symbol that has an underlying ticker symbol going through consolidation will be deactivated at that particular consolidation event. You will need to edit and reactivate these alerts. Please consult the Key Details section at www.schwab.com.hk/newoptionsymbols_en for detailed information on how to do this.
